Sierra Nevada: Natural & National Park

- **Foundation: 1989; 1991**
- **Extension: 172.238 Ha**
- **Biosphere Reserve by UNESCO**
- **Huge altitude and climate range**
- **Endemic nature**

Sierra Nevada Natural Park

- 2 Provinces: Granada and Almeria
- 5 Bioclimate ranges
- 26 Habitats
- Altitude from 300m to 3479m
- 2.100 different plants (66 endemic)
- 297 kinds of animals and more than 18.000 invertebrates

- 350 Snowgun



Sierra Nevada Resort border

- Inside of Natural Park
- Only a 1,41 % 
- Exclusive area C3 (Ski compatible)
- A restricted area close to National Park (B4 area)

Sierra Nevada Ski Resort

C3 Alpine Ski is a “Consolidated intensive use for snow sports area”

- Snow sport
- Snow grooming (and motor vehicle)
- Snow making
- Infrastructures for resort development
- Accident and rescue
- Movement of the snow





Sierra Nevada Ski Resort

Activities and new infrastructures, we need:

- 1.- Previous environment study ("AAU: Autorización Ambiental Unificada")
- 2.- Project approved by authorities of the Natural Area.
- 3.- Refocusing on the ground
- 4.- Special follow up by the environmental agent
- 5.- Natural recovery of the area
- 6.-A deposit of 10% of the investment (to remove the infrastructure in the future)

Sierra Nevada. Complementary Environmental Actions



- 1.- Environmental department
- 2.- Limited use of water for snowmaking
(350.000 m³)
- 3.- Efficiency use of water
- 4.- Reduction in energy consumption
- 5.- Recycling system (metal: iron, steel, aluminium; glass, oil,...)
- 6.- Wooden poles in slopes
- 7.- Cleaning days
- 8.- Greenhouse for endemic plants
- 9.- Sowing seeds on slopes
